- ❖ Alcove numbers 2, 3, 4, 5, 8, 9, 10, 11 & 12 approximately 304 sq. ft.\*display space. \$125.00 per month
- ❖ Alcove numbers 14, 15, 16, 18, 21, 22 & 23 approximately 429 sq. ft. \*display space. \$150.00 per month
- ❖ Alcove numbers 1, 6, 7, 13, 17, 19 & 20 approximately 453 sq. ft. \*display space \$175.00 per month
- ❖ Alcove number 7 Subdivision - 4 Mini Spaces-36 sq. ft wall space & a 36" display case \$80.00 per month
- ❖ Wall Space 8 ft. x 8 ft. = 64 sq. ft. 6 Spaces Available \$60.00 per month
- ❖ Glass Display Cases – four 36" cases & one 48" case Available \$60 & \$100 per month
- ❖ Meeting and demonstration space will be available to Member Artists.
- ❖ These rates include advertising, website presence, on-site demonstration/meeting room, utilities, sales staff, creative retail advisors and monthly accounting. Sales tax is collected and remitted to the state on your behalf.
- ❖ There is a 30% transaction fee on net sales for alcoves, 25% transaction fee for glass display cases, and a 15% transaction fee on net sales for wall space.
- ❖ The initial lease will be offered for a period of six (6) months.
- ❖ Member Artist must provide display poster with their picture and artist statement. In order to maintain consistency our staff will assist the artist in the development of the poster.

\*Display space is combined wall sq. footage and floor sq. footage.

The gallery is open to ceramics, drawings/pastels, enamel, painting, fiber, basket, leather, glass, metal, jewelry, mixed media, oil/acrylic, pottery, photography, printmaking/graphics, sculpture, watercolor and wood.

Only original-concept, handcrafted work by selling artist is accepted for exhibit.
